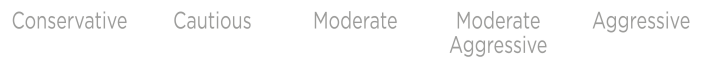


SPW SHARIAH EQUITY PORTFOLIO

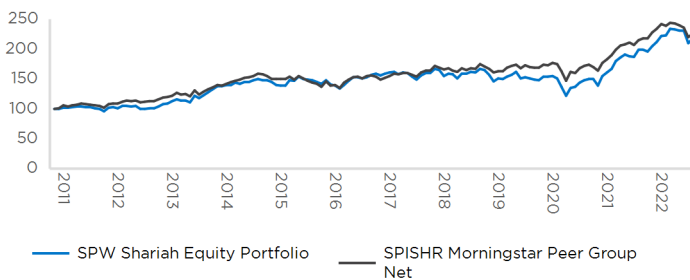
YOUR PERSONAL EQUITY PORTFOLIO

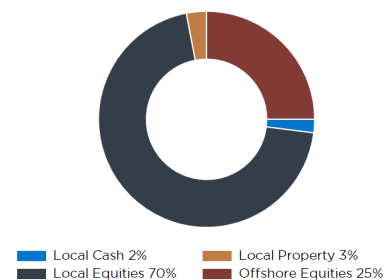

PORTFOLIO MANAGER'S COMMENTS

July saw a dramatic change in investor sentiment as the US Federal Reserve was perceived to pivot in its views regarding its policy path on the back of softening economic momentum and important drivers of inflation momentum starting to lose steam. Following a material sell-off in SA equities in the first half of the year, we saw a bounce in July - the FTSE/JSE All Share Index returned 4.2% in the month. Although this performance lagged that of developed markets, it has beaten that of its average peer group - the MSCI Emerging Markets Index advanced by 2.2% in July.

SA industrial shares returned 5.8% in the month, with personal goods (Richemont being the biggest constituent) the star performer. The sector gained 14.5% after Richemont posted good results and was rewarded by strong share price appreciation. Real estate investment trusts (+7.6%) bounced back markedly after a poor first six months of the year. Chemicals (Sasol) declined by 5.6% as the oil price softened.

Local bond yields fell late in the month in line with global peers. The All Bond Index returned 2.44% in the month. Cash yielded 0.4%.

The SPW Shariah Portfolio returned 3.78% (benchmark: 2.99%) in July. No changes were made to the portfolio during the month.
